Summary of role

To provide a safe, effective, motivational and enjoyable exercise environment, ensuring the safety and welfare of all the participants within the class. Assist in the provision of a high quality, customer orientated service.

Key Responsibilities

- To teach swimming following the Swim England National Framework.
- To complete group records of achievement for each class and take register at the beginning of a lesson.
- Arrive on poolside 5 minutes before lessons start, commence and finish the class at the programmed time.
- To collect all required equipment from the designated store area prior to the class commencing.
- During a pupil's first lesson, screen the pupil to ensure they are correctly placed.
- To provide a safe, informative, fun and productive lesson.
- To ensure all pupils leave the pool teaching area before the teacher leaves.
- To store all equipment used during lessons in the designated store area in a safe and tidy manner
- Assess pupils against the Swim England National Plan for Teaching Swimming and record assessments on tablets.
- Following site procedure, carry out pupil class transfer as required.
- Sign and complete certificates when required.
- Inform the Swim Co-ordinator of any issues regarding pupil problems.
- Inform the Swim Co-ordinator or Duty Manager of any damaged or required equipment.
- To attend two swimming teacher meetings each year.
- To attend a minimum of two training sessions a year (agreed with the Swim Co-ordinator).
- To adhere at all times with Health and Safety requirements necessary whilst carrying out duties of the post.

- Be fully aware of the Centre's Normal Operating Procedures and Emergency Action Procedures.
- Customers Face to face, Recreational Supervisors, Managerial staff, Swimming Academy Co-ordinator, Childrens Programme Team.
